Dental Care Membership Program

We are pleased to announce that we now offer a Dental Care Membership Program to all of our patients that do not have dental insurance. If you do not have insurance this plan is designed to provide affordability and easy access to quality dental care.

Included in your annual membership fee are the following services:

- 2 exams
- Oral cancer screening/exam
- All needed x-rays
- 2 professional cleanings per year
- An emergency exam or consultation (if needed)
- 2 fluoride applications per year (child plan)
- Plus - a 10% discount on any additional regular priced treatment with cash or check, or 8% discount when paid by credit card. (Payment must be made day of service. **Discount will not apply if using CareCredit**)

Plus, there are:

- No waiting periods
- No annual maximums
- No deductibles
- No exclusions for cosmetic or elective care

This is not dental insurance. It is a wellness program for exclusive use at **Gregory Owens, DDS**. Contact our office today if you'd like to learn more, or if you would like to schedule your initial appointment. 276-676-2616

Annual pricing for plans:

- **Adult Membership** - 13 & older \$300.00 - savings of at least \$87.00 per year - not including discounts received for other treatment-if needed. (At least \$163.00 savings for a new patient.)
- **Child Membership** - ages 6- 12 \$275.00 - savings of at least \$145.00 per year - not including discounts received for other treatment-if needed. (At least \$229.00 savings for a new patient.)

- Your membership is effective immediately after annual dues are paid
- Dental Care Membership **will expire one year** from date membership is taken out and membership will be up for renewal at this time. A renewal statement with annual charges will be sent out one month before renewal date. It is your responsibility to keep your mailing address updated so that you will receive your statement.
- Payment for additional treatment is required day of service to be eligible for discount.
- Membership may be canceled at any time, however, refunds will not be provided for dues paid under any circumstances, including failure to schedule and maintain appointments.
- Your membership program is solely with our office and is non-transferable. If you move to another area, you may cancel your membership at any time.
- Sometimes it is necessary to refer to a specialist, the specialist will charge you the fee that they have set for their practice. No discount will apply.
- Due to insurance regulations this membership program is only offered to our patients with no dental insurance. (This plan also excludes any treatment benefits paid from workers compensation and auto medical)
- If you are a patient that requires more than 2 professional cleanings per year, we will only charge for additional professional cleaning (no exam fee) and you will be able to apply discount to any additional cleaning visits as well. (Example 3-4 month wellness recall patients)

Legal & Disclaimers

Membership plans are not insurance but a payment arrangement provided by **Gregory D Owens, DDS** for services rendered. Memberships are provided exclusively to uninsured patients of our practice and shall not be considered pre-payment for future services or payment for access to discounted services. Rather, our patient members are electing to make regular annual subscription payments for preventive care instead of paying at the time of each service. Payment for any treatment is due at the time of service. Membership dues must be current in order to receive services. A lapse of 28 days in dues will require a reactivation fee of \$99. Membership club discounts may not be combined with any other offers or discounts. It is solely the patient's responsibility to schedule and keep their appointments. No refunds will be provided for dues paid under any circumstances, including failure to schedule and maintain appointments. A patient member's annual agreement is with the legal entity of **Gregory Owens, DDS**. Annual dues and fees for dental services may change at any time.
